**QUARTERLY ACTIVITIES REPORT

**REVIEW of OPERATIONS  
GUNNEDAH BASIN COALBED METHANE PROJECT  
PETROLEUM EXPLORATION LICENCES 1 AND 12, NSW (GUNNEDAH BASIN)**

*These tenements are held by wholly owned subsidiary, Australian Coalbed Methane Pty Ltd (ACM) and are subject to a Joint Venture (JV) with Santos QNT Pty Ltd (Santos). Santos holds a 65% interest in the tenements and is the project Operator.*

Field operations during the quarter included routine inspection and maintenance of existing wellheads, surface facilities and access tracks.

During the reporting period, the Operator completed supporting studies to progress finalisation of Reviews of Environmental Factors (REFs) relating to planned PEL 1 and PEL 12 work programs, including:

- Reactivation and operation of the Kahlua multi-well pilot (PEL 1) and
- Bando Seismic Survey (PEL 1).

During the reporting period, the Bando Seismic Survey REF was lodged with the Resources Regulator within the NSW Department of Planning and Environment for assessment. This has now been approved, with planning undertaken for the seismic work. The REF for reactivation and operation of the Kahlua pilot was finalised and lodged 12 January 2023.
