**QUARTERLY ACTIVITIES REPORT

**REVIEW of OPERATIONS
GUNNEDAH BASIN COALBED METHANE PROJECT
PETROLEUM EXPLORATION LICENCES 1 AND 12, NSW (GUNNEDAH BASIN)**

These tenements are held by wholly owned subsidiary, Australian Coalbed Methane Pty Ltd (ACM) and are subject to a Joint Venture (JV) with Santos QNT Pty Ltd (Santos). Santos holds a 65% interest in the tenements and is the project Operator.

Field operations during the quarter included routine inspection and maintenance of existing wellheads, surface facilities and access tracks.

During the reporting period, the NSW Government renewed exploration licences PEL 1 and PEL 12, with the Licences taking effect from 12 April 2022 for six years until 12 April 2028. The Licence conditions include undertaking an agreed work program. In Year 1 (12/4/22 to 12/4/23), the program includes:

- Reactivation and operation of the Kahlua multi-well pilot and
- Geological studies.

A technical committee meeting was held on 6 June 2022 to further discuss the planned work program and budget for on-ground activities in Petroleum Exploration Licence (PEL) 1 and PEL 12 during calendar year 2022.
