**REVIEW of OPERATIONS  
GUNNEDAH BASIN COALBED METHANE PROJECT  
PETROLEUM EXPLORATION LICENCES 1 AND 12, NSW (GUNNEDAH BASIN)**

*These tenements are held by wholly owned subsidiary, Australian Coalbed Methane Pty Ltd (ACM) and are subject to a Joint Venture (JV) with Santos QNT Pty Ltd (Santos). Santos holds a 65% interest in the tenements and is the project Operator.*

Field operations during the quarter included routine inspection and maintenance of existing wellheads, surface facilities and access tracks.

The Operator continues to progress tenure commitments including completion of the Bando Seismic Survey and finalising plans for the execution of the approved Kahlua area activities.

Further exploration activities will be undertaken to deliver on the tenure commitments, and to better understand NSW's resource potential with a view to ensuring long-term energy security and affordability for the state.
