# REVIEW of OPERATIONS GUNNEDAH BASIN COALBED METHANE PROJECT PETROLEUM EXPLORATION LICENCES 1 AND 12, NSW (GUNNEDAH BASIN)

These tenements are held by wholly owned subsidiary, Australian Coalbed Methane Pty Ltd (ACM) and are subject to a Joint Venture (JV) with Santos QNT Pty Ltd (Santos). Santos holds a 65% interest in the tenements and is the project Operator.

Field operations during the quarter included routine inspection and maintenance of existing wellheads, surface facilities and access tracks.

A management committee meeting was held on 31 January 2022 to discuss the work program and budget for planned Petroleum Exploration Licence (PEL) 1 and PEL 12 activities in calendar year 2022 and timing of renewals of these licences.

In late March 2022, the NSW government supplied PEL 1 and PEL 12 renewal documentation to Santos that were reviewed by the JV parties in the reporting period. Santos continues to liaise with the relevant agencies on this matter with a government decision on award of PEL 1 and PEL 12 expected early in the second quarter of 2022.
